USW activists talk community, bargaining power at District 10 Civil and Human Rights Conference

Members and activists of USW local unions across Pennsylvania gathered at Linden Hall for the District 10 Civil and Human Rights Conference the week of Oct. 31 to learn how to use bargaining power as a tool for change.

The roughly forty members participated in workshops focused on understanding power and privilege, fighting anti-LGBTQ+ discrimination, forming and utilizing Civil and Human Rights Committees within local unions, and unpacking how racism impacts health and safety. They also learned how to utilize social media and texting campaigns to engage their membership.

DeLisa Baldwin of Local 1688 said another way to get members involved and build strength as a union is to get out into the community.



"Our plant is in the middle of the city," she said, "so it's important for our union to volunteer and be seen and let them know we're here and we care."

Members at the conference also participated in the USW Health Care Workers Council's firstever workshop focused on protecting members' access to medical and reproductive health care. Council Coordinator Tamara Lefcowitz outlined a new toolkit available to members and also detailed how local unions can bargain language in their contracts that benefit rural workers, including coverage of out-of-state travel expenses for specialty care like chemotherapy.

"Firstly, we want members to be educated on their right to ask for information from their employers," said Lefcowitz. "We also want to promote the many different resources the union has available and the different paths members can take to protect each other."

USW Vice President of Human Affairs Kevin Mapp ended the week with an address that called for holding the line and holding onto hope amidst the many challenges facing the labor and civil rights movements.

"It truly is going to take each and every one of us, as individual labor activists, to meet people where they are and move with them into the future," said Mapp on Thurs., Nov. 3., the final day of the conference.

District 10 Director Bernie Hall also closed out the conference with a reminder of the importance of union members using their collective power to fight for the working class.

"If it weren't for unions, no one would be out there advocating for workers and lobbying legislators on behalf of our interests," said Hall. "We have to show up face-to-face."

Mapp handed out certificates to everyone who completed the week's seminar, along with District 10 Civil and Human Rights Coordinator Leroy Atwater, who invited the members to keep the work they did at the conference moving forward.

"The best part about this week is the fellowship" Atwater told them. "All we ask now is that you take something you learned here back to your locals."

Make the Call: Tips for Making Calls to Congress

Our experience from over 20 years of Rapid Response actions is that calls matter and our voices have power. They bring awareness to an issue and influence lawmakers. The more calls, the more impact.

Here are tips for making calls to Congress, especially for first-time callers:

I'm not sure who to call.

Our toll-free number makes it easy. When you dial the number provided on a Rapid Response Action Call for the first time, you will be asked for your zip code. That number will route you to the correct Senator or Representative. If you are asked to call both Senators, call a second time to be automatically routed to your other Senator.

Who picks up the phone?

Staff assistants or interns typically answer calls. For some offices, a recording plays and then you are given the option to leave a message.

I'm not that familiar with the issue. What do I say?

Don't feel like you need to be an expert. Whenever Rapid Response asks for calls, we include suggested things to say. Most importantly:

- -Tell the person your name and where you are from. It is important for the office to know you live in the district or state they are representing.
- -Share your position on the issue you are calling about. Make sure to reference the bill number, the name of the bill, and any other pertinent information (reference the Rapid Response information for these details).

How long does it take?

Most calls only take a minute. The staffer answering the phone often only wants to know who you are, where you are from, and if you support or oppose an issue so it can be noted. That's it!

I've never called before. I'm nervous!

Most people are surprised at how easy it is after making their first call. However, you can also call after business hours and leave a message on your Senator or Representative's voicemail.

What if i want my call to make a bigger impact?

Ask to speak with the legislative aide who handles the topic area you are calling about. Share how the issue relates to you and your members. Ask for a response from the office. Get others to join you in making a call. When groups of people are calling at the same time, an office is forced to take note!

I wasn't able to get through. Now what?

Sometimes when Congress is debating a major issue, high call volume can overwhelm an office. You can try calling the district offices instead.

Please report to Rapid Response if this is happening. Find out the phone numbers by looking up your Representative or Senators at www.house.gov or www.senate.gov.

Calling State Lawmakers: Every state has a different structure. We will adjust our instructions on Action Calls as needed. Most of the same principles for calling U.S. Senators and Representatives apply. For the greatest chance of easily connecting with your state lawmakers, join our mobile alerts and make sure to provide your address: text USWRapid to 69866.

Rapid Response information is shared through email. We also text action requests and information.

- -To sign up for emails, visit the Rapid Response website at www.uswrr.org.
- -To sign up for texting, text uswrapid to the number 69866. We don't text often only when it really counts! You can stop at any time. Standard rates apply.

UNITED STEELWORKERS **EMERGENCY RESPONSE TEAM**

What is this USW Emergency Response Team also known as the ERT team that we hear about? When do we need to notify the team? Is it mandatory participation? Who is on the team and what do they do?

These are all commonly asked questions that ERT team members hear at conferences, classes, Local meetings, and other gatherings of union members.

The USW merger with PACE in 2005 was in many ways a positive action. One program that came from PACE was the Emergency Response Team program which was adopted by the USW and mandated to be part of the newly merged entity, however; participation of the locals is optional during an incident. It is highly recommended to initiate the call when incidents happen for the best result and not having to "catch up" on valuable lost time as the incident evolves. The ERT Coordinator only works with the victim, family, Company officials, and the Local officers. The Safety Reps work with the Local officers, OSHA, and Company to investigate the incident scene etc. ERT and Safety Reps purposely DO NOT interact during incidents to best achieve our result.

Typically, workplace emergencies consist of "life altering" or "a fatality" or "both" in the USW represented facility. At that time, it is up to the Union member, Local President, or District Staff Rep to call and notify the Emergency Response Team Hotline. Please remember that your Local President which will contact the the injured party need not be a local member but rather an injured person on the USW represented plant. Outside contractors, other union affiliates, and even in some cases, company staff. In the case of a non-USW member, the ERT Coordinator will come in and do initial contacts and then hand over to the other Union affiliate staff or Contractor companies to proceed with the incident or continue with the coverage if needed.

THE HOTLINE IS AVAILABLE 24 HOURS A DAY AT 866-526-3480

When a call is made, please be patient and answer all the questions being asked as this will help in the correct services being dispatched to the incident if warranted. The on-

call members include the ERT program Coordinator Duronda Pope. There are roughly 62 (+ -) ERT coordinators nationwide to handle incidents in the USA, Canada, and Puerto Rico. Along with the ERT Coordinators, the USW Health, Safety, and Environmental staff or Health and Safety Reps. An incident happens roughly every 8 days of the year.

The purpose of ERT is to assist families and coworkers, to work with the Local Union officers and to provide follow up support, as well

- To serve as victim advocates
- Coordinate support for victims and families
- Finding lodging for the family members in the area where the injured member is being treat-
- Act as a liaison between families and the employer and families and the local union
- Provide referrals to local therapists who understand the needs of organized labor and those dealing with loss and trauma
- Continued follow up with those involved in the incident
- Gather information about the health benefits and insurance of the injured member
- To provide mental health resources to families and affected co workers

Hopefully most of the questions that you may have about the program have been answered. If not, please see a District ERT Coordinator or a Local Union officer to put you in touch with one of the Coordinators. Want to be considered for an ERT Coordinator position? Contact Staff Rep and District Director.
