### THINGS THAT MAKE YOU GO HMMM

Members received a letter from Northern Illinois Health Plan informing you of an Approved Medical Reimbursement Plan (AMRP), a plan that the Union did not agree to and never saw before being mailed out to our members. This is not what the negotiating committee wanted for our members. This plan was to be jointly put in place and agreed upon with the Union, the District, and 3rd party. This did not happen and is a violation to our members. This violation is being put into the hands of our legal staff. The letter also stated that your monies would be from January to December as if there is any longer a roll over. You will not lose your unused funds, they will roll over. Any money remaining from the HRA fund should still exist and is available to use.

The safety aspect in some buildings remains. Due to the seriousness of this matter, I ask the question, "If all Para's had received the Hepatitis B shots?" In return I was told that "We can't make Para's go get the shots, all we can do is make them available." How are our members being told about these shots and are they being explained the importance of the shots and what could happen if shots are not received? Yes, the shots are available but it's important that ALL Para's realize that if blood is drawn and or skin broken due to being bitten and or scratched, it is your right to go

immediately to Burchard Hill and start the Hepatitis B shot series. This is very important to your health and wellbeing. The Hepatitis B Shot series is given in three shots. The first one is given that day, the second one is given in 1 month after the first and the 3rd is given 3 months after the second shot. If a 4th shot is necessary, that would be given within two months of the third, having received all shots within 6 months. Please ask questions and know your rights. These shots are no cost to you. After receiving the shots, if bitten or scratched causing broken skin, make a written documented report to the building nurse. The nurse in return should call the parent and inform parent of the need for a blood draw. Based upon the result of the blood work, the Para should be informed of the results.
