Our USW unit consists of paraeducators, food service, security, and IMT's. You GNC (Andrea Misek, Denise Hayunga, Cindy Erb, Ricky Robinson, and myself) have begun the process of writing proposals to get ready to negotiate our next contract. As of now, we anticipate a mid/late April date to begin negotiating with the District.

Mary Meier, our secretary at the USW hall, compiled the surveys classified staff completed in December and put them in categories from what members thought was most important to least. Mary also included comments and member ideas on her spreadsheet. Trust me, she is a God send! While an increase in wages was by far the number one response members wanted to see happen, all suggestions made on the

surveys will be taken into consideration when writing proposals. Thank you to those who completed the survey and making our job a little bit easier.

I want to update you on the Arbitration case regarding assistant cooks and the District having them acquire and maintain a managerial license (head cook). The District's stand is that there was a new Mandate making this change necessary in 2019. However, USW maintains that there was not a change in the requirement of this Mandate, nor was it new, making this instead a change in the condition of employment, changing their job description, and a contract violation.

While that is still ongoing, the District has agreed to reimburse any food service employee who has paid out of pocket to retake the managerial license test one or more times. This reimbursement should have been on your January 31<sup>st</sup> paycheck. If you have paid out of pocket to take this test and were not reimbursed, let me or a GNC member know ASAP.

### THE MORE YOU KNOW . . .

#### **Weingarten Rights**

"If this discussion could in any way lead to my being disciplined or terminated, or affect my personal working conditions, I respectfully request that my union representative, or steward be present at this meeting. Until my representative arrives, I choose not to participate in this discussion."

In 1975 the US Supreme Court upheld a National Labor Relations Board decision that employees have the right to union representation. If you are ever called in for a meeting with an administrator and feel the conversation is disciplinary, tell the administrator that you are enforcing your Weingarten Rights. By law the meeting will have to stop until a union representative can be present.

I was so proud this year when a paraeducator enforced her Weingarten Rights not once but twice when her building principal called her to the office on two separate occasions for what the para felt was going to be disciplinary.

It can be hard to stand up for yourself but in this case not only is it your right, it is the law.
