




International Constitution



Standard Local Union By-Laws




Standard Amalgamated Local Union By-Laws






How A Stand Alone Local Works:






How An Amalgamated Local Works:

That's My Job:

No. 1: Audit books and financial records of the local every three months and issue an audit report at the next regular local union meeting.

This is the duty of

The Trustees per Art. V, Sec. 8 of SLB/SALB.



That's My Job:

No. 2: See that all present at the local union meetings are entitled to be there.

This is the duty of

The Guide per Art. V, Sec. 6 of SLB/SALB.



That's My Job:

No. 3: Appoint all unit committees not otherwise provided for and serve as ex officio member of all unit committees.

This is the duty of

The Unit President per Art. V, Sec. 9(a) of SALB.



That's My Job:

No. 4: Receive all money due the local union and issue a detailed report at least once a month at the local union meeting that covers all receipts and expenditures.

This is the duty of

The Financial Secy. per Art. V, Sec. 4(a) & (e) of SLB/SALB.



That's My Job:

No. 5: Have charge of the local union hall and all the local's property.

This is the duty of

The Trustees per Art. V, Sec. 8 of SLB/SALB.



That's My Job:

No. 6: Call special meetings when requested by 10 members in good standing.

This is the duty of

**The Local President per Art. V, Sec. 1(b) of SLB/
SALB.**



That's My Job:

No. 7: Assist the President in the discharge of his/her duties and perform such duties in the President's absence.

This is the duty of

The Vice President per Art. V, Sec. 2 of SLB/SALB.



That's My Job:

No. 8: Preside over all local union meetings and decide all questions of order subject to appeal to the local union.

This is the duty of

The President per Art. V, Sec. 1(a) of SLB/SALB.



That's My Job:

No. 9: Process bargaining unit complaints/grievances in accordance with the appropriate collective bargaining agreement.

This is the duty of

The Unit Griever(s) per Art. V, Sec. 9(c) of SALB.



That's My Job:

No. 10: Appoint all local committees not otherwise provided for and serve as ex officio member of all local committees.

This is the duty of

The President per Art. V, Sec. 1(c) of SLB/SALB.



That's My Job:

No. 11: Make out and forward various reports required by the International Secy.-Treasurer.

This is the duty of

The Financial Secy. per Art. V, Sec. 4(a) of SLB/SALB.



That's My Job:

No. 12: Cast the deciding vote when members are equally divided.

This is the duty of

The Local President per Art. V, Sec. 1(a) of SLB/SALB.



That's My Job:

No. 13: Record all proceedings of the local union, read and file all correspondence, and have custody of the local union seal.

This is the duty of

**The Recording Secy. per Art. V, Sec. 3(a) & (b) of
SLB/SALB.**



That's My Job:

No. 14: Such other duties as the local union (or unit) may assign.

This is the duty of

- The Recording Secy. per Art. V, Sec. 3(a) of SLB/SALB.**
- The Financial Secy. per Art. V, Sec. 4(a) of SLB/SALB.**

- The Trustees per Art. V, Sec. 8 of SLB/SALB.**
- The Unit President per Art. V, Sec. 9(a) of SALB.**
- The Unit Secy. per Art. V, Sec. 9(b) of SALB.**
- The Unit Griever(s) per Art. V, Sec. 9(c) of SALB.**



That's My Job:

No. 15: Insure that funds and property of the local are preserved, managed, invested, and expended in accordance with the Intl. Constitution, Local Union By-Laws, and various manuals and policies of the Intl. Union and the Local.

This is the duty of

The President, the Financial Secy. & the Treas. per Art. V, Sec. 10 of SALB/Sec. 11 of SALB.



That's My Job:

No. 16: Enforce the provisions of the Intl. Constitution, the Local By-Laws, and the policies and manuals of the Intl. Union.

This is the duty of

The Local President per Art. V, Sec. 9(a) of SALB, and all Local and Unit officials per Art. V, Sec. 9 of SLB and Art. V, Sec. 10 of SALB.



That's My Job:

No. 17: Preside over all unit meetings and decide all questions of order subject to appeal to the local union.

This is the duty of

The Unit President per Art. V, Sec. 9(a) of SALB.



That's My Job:

No. 18: Sign all the local union's checks.

This is the duty of

The Local President, Financial Secy., and Treasurer
per Art. V, Sec. 5(a) of SLB/SALB.



That's My Job:

No. 19: Maintain books for examination by the Intl. Secy.-Treasurer and the Trustees.

This is the duty of

The Financial Secy. per Art. V, Sec. 4(a) & (d) of SLB/SALB.

The Treasurer per Art. V, Sec. 5(b) of SLB/SALB.



That's My Job:

No. 20: Record the attendance and proceedings of the unit and read and file all papers.

This is the duty of

The Unit Secretary per Art. V, Sec. 9(b) of SALB



That's My Job:

No. 21: Take charge of the door at union meetings and see that no one enters who is not entitled to do so.

This is the duty of

The Guard per Art. V, Sec. 7 of SLB/SALB.



Amended By-Laws Must:

- ✓ Take the form of a new section or subsection and cannot be construed as superseding any provisions of the International Constitution or the policies and manuals of the International.
- ✓ Be submitted to and approved by the International.
- ✓ Be submitted in writing and read at two consecutive local union membership meetings.
- ✓ Be advertised to the membership through bulletin boards or other media prior to the membership meeting at which they'll be voted on.
- ✓ Passed by a two-thirds majority vote of the members present at the next regular meeting.

Tips for Chairs:

- Let others carry the ball.
- Be neutral – call on all members who asked to be recognized on an impartial basis.
- Cut-off cross discussion, meaning direct members to address themselves to you and the entire meeting.
- Don't tolerate interruptions of speakers unless permitted by a parliamentary exception such as a point of order.
