



NOMINATION MEETING NOTICE

USW LOCAL 9460, District 11

February 24, 2021

The Local Union Executive board has determined that due to the Covid-19 pandemic the Local is unable to safely hold an in-person nomination meeting. On a one-time basis due solely to Covid-19, nominations for the Local Union Offices of President, Vice President, Financial Secretary, Treasurer, Recording Secretary, Guide, Guard (Inner), Guard (Outer), three trustees, Unit President, Unit Secretary and Unit Griever will be accepted in writing, or by submitting the nomination to the Local Recording Secretary by postal mail and/or the designated drop box.

As provided in the USW Elections Manual, any member who has paid their initiation and is in good standing at the time of nominations is eligible to nominate candidates. To be eligible for office, a member must have been in continuous good standing for a period of twenty-four months immediately preceding the month in which the election is held (April 2021). In addition, the Local is waiving the 1/3 meeting attendance requirement as a condition of eligibility for nominees. Self-nominations are permitted. The term of office will run for three years beginning May 18, 2021.

Only members in good standing may submit a nomination in writing to the Local's Recording Secretary which must be received no later than 5:00 PM on Friday **March 19, 2021**.

Nominations for Unit positions can only be made by members of that Bargaining Unit. No electronic submissions are permitted. All nomination submissions must include the following information printed *legibly*:

"I, _____ nominate: _____ for the office of _____."

(your first & last name) (candidate's first & last name) (union position)

(candidate's current contact information; phone, personal email, etc.)

(your signature) (your phone number) (your bargaining unit) (Date signed)

The above is an example of how nominations are to be submitted and is NOT intended to serve as an official form.

The drop box for submitting nominations is located inside the Duluth Labor Temple at 2002 London Road, Suite 200. Available Monday through Friday from February 25, 2021 through March 19, 2021 from 9AM- 5:00PM. (Please call 218-724-5223 when you arrive, as the doors of the Duluth Labor Temple are locked to the public).

Nominations will be tabulated at the Duluth Labor Temple on **3/19/21 at 5:01PM**. Observers are welcome but must call ahead to RSVP and adhere to strict Covid-19 safety requirements including wearing a mask and social distancing.
