USW Local 105 General Election Reminders:

Ballots have been mailed out and many eligible voters have recently received them. If you haven't received your ballots in the next day or two, please call the hall at 563 355-1181 and let us know. We can let you know the address it was mailed to and you can either request a replacement ballots or wait to see if your election packet gets forwarded to you if you have had a change of address.

If you are missing any of the ballots, please let us know and we can send you a duplicate ballot. DO NOT MAIL IN WHAT YOU HAVE until you have all the ballots.

Cast ballots must be mailed back in the stamped preaddressed return envelope enclosed in your ballot packet in time to arrive at the PO BOX by April 22. This way only the election tellers will have access to them, and they will be able to tabulate the results.

Have You Been Fully Vaccinated?

People are considered fully vaccinated:

- 2 weeks after their second dose in a 2-dose series, such as the Pfizer or Moderna vaccines, or
- 2 weeks after a single-dose vaccine, such as Johnson & Johnson's Janssen vaccine

If you don't meet these requirements, you are NOT fully vaccinated.
