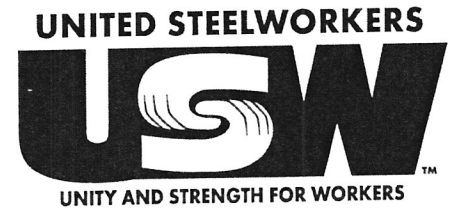

Arconic Proxy Voting

I am still suggesting that everyone vote the white proxy. Even though CEO Klaus Kleinfeld has stepped down I believe it is in our best interest to keep the remaining board in place.

I have had members report to me that they did not receive any proxy voting information. Here is the response from corporate HR:

Employees may not be understanding that they were not investing in the Arconic Stock Fund in their Savings Plan on March 1, 2017 (the record date) and therefore do not have a right to vote for the proxy. In order to have a right to vote you had to be invested in the Stock Fund on March 1, 2017.

As a reminder we haven't automatically invested the company match in the Stock fund since January 1, 2014. If you are unsure of your investment selections they can call 1-844-

Benefit News

Based on concerns from some of the membership about the out of pocket cost for 3D mammograms we did some research and found out the following:

Some local providers believe that 3D mammograms is an additional cost of \$60 for our members, this is not the case.

A 3D mammogram is called Tomosynthesis and is eligible under the Arconic benefits. It would be eligible at 100% with an in network provider, just like a regular mammogram.

3D mammography is the clinically proven to be superior to a regular 2D mammogram.

Studies have shown that 3D mammography detects 41% more invasive breast cancers and reduces the chance that you will need to

be called back for additional screenings by up to 40%.
