THINGS THAT MAKE YOU GO HMMM

If you are a member and feel that you are being falsely accused causing unjust discipline to your record and personal file, you have rights.

ARTICLE X: GRIEVANCE PROCEDURE

Any claim by the Union or an employee that there has been a violation, misinterpretation or misapplication of the terms of this Agreement shall be a grievance. The parties hereto acknowledge that it is most desirable for an employee and the employee's immediately involved supervisor to resolve problems through free and normal communications. If, however, the informal process fails to satisfy the employee or the Union, a grievance may be processed.

Step One:Mr. Chris ShockeyStep Two:Mr. Patrick McDermottStep Three:Dr. Michael SchiffmanStep Four:Arbitration

If the Union is not satisfied with the disposition of the grievance at Step Three, or the time limits expire without the issuance of the Board's written reply, the Union may submit the grievance to binding arbitration. For more information, see pages 28 & 29 in your contract.
