On Tuesday, March 18, we were told a 'pop-up' school was in the works at the Boys and Girls Club. I didn't know how that could be possible but in this case it truly took a village. The King Center opened their arms to us. Head Start moved their classroom

upstairs to make extra room for our kindergartners. Grade levels from different schools sent over supplies, worksheets, and books. Food service supplied us with snacks and meals for our kids. On Wednesday, March 19, we opened doors at the King Center for 82 students, and for the 20 and 21 we averaged roughly one hundred each day. The kids were grateful and happy to be at 'school'. As a staff we ended the day on the 21st exhausted and humbled by the love we received from everyone.

Writing this during spring break I am told that Taylor Park is anticipated to be open after break. Please keep your thoughts and prayers coming that this happens.

The Classified Advisory Council brought up in the March meeting to administration the ability to have food service employees make up the 6 Act of God days **if they choose to**. Paraeducators are given the opportunity so why not food service? HR is looking into different options for food service to make up these hours. THE MORE YOU KNOW . . .

“Probationary Period: All employees hired on or after July 1, 2011, will serve a probationary period for 80 school days following each employee’s first day of active employment in the District, during which time the employee may be discharged for any reason in the sole and non-reviewable discretion of the Superintendent. Probationary employees who are in positions qualifying for District-provided health insurance will be eligible for health insurance benefits on the first day of active employment.”

This contract clause is pretty self-explanatory. This means for the first 80 school days of employment with the District you can be terminated for any reason at any time. We have had this happen this year. Do your best, watch your sick day usage, be on time, and notify us if you are having any conflicts or problems. It is our desire to assist you in making your job with FSD a fulfilling one.

Rice Krispie Peep Treats

- 7 cups Rice Krispies, divided
- 9 4-count packages of peeps, in three different colors
- 4 ½ T butter, divided

Directions:

1. Grease a 8 x 8” baking dish with cooking spray and line with parchment paper. Then grease parchment paper with cooking spray.
2. In a medium, microwave-safe bowl, combine 2 1/3 cups Rice Krispies, 12 peeps of one color, and 1 ½ T butter, then microwave until Peeps expand and butter is melted, about 40 seconds. Combine until fully mixed.
3. Spread Peep mixture into baking dish then press to flatten. Repeat with remaining colors.
4. Refrigerate until solid, about 15 minutes. Slice, serve, and enjoy!
