A FEW THOUGHTS FROM THE UNIT CHAIRMAN

Welcome to November and the season of Thanksgiving!

As we all know, para shortages are across the District. That is due in a large part to the change in the law requiring new paraeducators to now hold 60 college credit hours. Until this is reversed and to once again allow the ParaPro test for new paraeducators, we will most likely remain short staffed. Chris Shockey and Jack Code recently asked to meet with me and USW President Kip Kuhlemeier. The K-2 PACC room at Lincoln Douglas is dangerously understaffed and they wanted to meet with us to think of ways together to fix the problem. Three "solutions" were found:

1. A voluntary transfer of paras into this room.
2. An offer of a \$500 stipend to any para in a PACC, SITE, or SELF room.
3. An involuntary transfer of paras into this room.

The email I sent out to all paraeducators asking if anyone would consider a

voluntary transfer did not yield any results, so that solution is crossed off the list.

The \$500 stipend has people asking questions. To give all paraeducators this stipend would not address the serious problem of being understaffed in these areas. The paras in these rooms are asked to handle more demanding duties on a daily basis. Because of this, paras are choosing not to fill these positions. It is our hope that this stipend will help entice paras to staff these areas. A copy of the proposed memorandum is on school union bulletin boards. Please take a moment to look it over. There would be a \$250 payment initially and a \$250 payment at the end of the school year. You would also have to pay back the initial payment if you do not stay at your position in one of these three rooms. Many USW Classified members already hold positions in these rooms at schools all across the District. These paras will also receive this stipend if they already work in a Site, PACC, or Self room.

Jenny Heiden, payroll at the board office, asked that USW make a slight change

THE MORE YOU KNOW . . .

Probationary Period: All employees hired on or after July 1, 2011, will serve a probationary period for eighty (80) school days following each employee's first day of active employment in the District, during which time the employee may be discharged for any reason in the sole and non-reviewable discretion of the Superintendent.

Probationary employees who are in positions qualifying for District-provided health insurance will be eligible for health insurance benefits on the first day of active employment.

Many new hires do not even know that they have a probationary period of 80 school days following their first day of employment with FSD 145. Don't let this make you nervous. Show up on time, take the appropriate break time and watch cell phone usage during working hours. It is rare that someone is actually terminated during their probationary period. Become proactive and get familiar with this and all areas of our contract. Read it, if you can't find your copy it is also posted on the FSD school website. Remember, the more you know...
