A FEW THOUGHTS FROM THE UNIT CHAIRMAN

2020 is here! The start of a new decade is upon us, filled with promise and hope--also strength. As union members, without strength we have no power. And without power, do we really have much of a union? It can be difficult to stand up for what is right. But unless we stand up together, we give our strength and the power of our contract away. Let's never let that happen!

This brings me to something I would like to inform you of. I addressed this on our **USW Classified Staff of FSD 145** Facebook group, but it is important that all members are aware what is happening. In February of 2019, assistant cooks were told that there was a change in the IL Food Code and they now had to hold a (head cook) managerial license. They also received a letter on April 16th stating that if they did not obtain this license, they would not be able to return to work.

I need to talk about how the above is a violation of our contract and should not have occurred.

First, this changed the condition of employment for assistant cooks by making them obtain and maintain a managerial license that was not in their job description. Second, the threat of termination was made if employees did not comply.

It is also important to note that there was **NOT** a change in the requirement of the IL Food Code. What this means is that it was not necessary for assistant cooks to achieve this license. If the District wanted assistant cooks to be licensed, they needed to notify USW and sit down and bargain. That was not done.

Because of these infractions, the grievance process was started and has gone through Steps 1-3. The GNC recently met and decided to move this case on to Arbitration. While this is something we would never decide on lightly, to accept the District's side that a violation was not made would weaken our contract and set a precedent for similar situations to happen in the future. This is a perfect example why it is so important to notify the union if something is going on that doesn't seem right or

THE MORE YOU KNOW . . .

Probationary Period: All employees hired on or after July 1, 2011, will serve a probationary period for eighty (80) school days following each employee's first day of active employment in the District, during which time the employee may be discharged for any reason in the sole and non-reviewable discretion of the Superintendent. Probationary employees who are in positions qualifying for District-provided health insurance will be eligible for health insurance benefits on the first day of active employment.

This is a topic that gets talked about frequently but is easily forgotten. Did you know that this school year alone we have already lost two Classified members to this clause in our contract? Now is a perfect time to be reminded that we all should stick together and help one another. Being a proud USW member means strength and solidarity. Remind new hires of protocol and rules, and also contact a GNC member if you see a new hire struggling so we can step in to help. Let's work to make this year one of successes!
