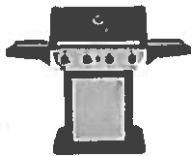

### Will Preparation

Preparing a will is an important life-planning activity that helps you secure your family's financial future and allows you to make important decisions about the distribution of your assets upon your death.

Employees and retirees who are covered by company-paid group term life insurance are eligible for the Will Preparation Service. This service gives you access to participating attorneys who will prepare or update your and your spouse's will, at no cost to you.

You may also use a non-participating attorney and receive reimbursement for covered services according to a set fee schedule. If you use a non-participating attorney, you will be responsible for any fees that exceed the scheduled amount and you will need to file a claim for reimbursement of the covered amount.

Living wills, powers of attorney, living trusts, and tax planning services are not covered by the Will Preparation Service.

As a member owned financial institution Ascentra Credit Union recognizes the importance of doing whatever possible both in good times and in bad to serve our membership. We've found over the years that many of our members who work for Arconic have been concerned about the possibility of a work stoppage as the company and union work on a new contract agreement. Rest assured we will be here to serve you if a work stoppage occurs.

As in the past, the credit union will grant extensions on your loan payments should you need them. It is always in your best financial interest to make these payments if you are able as interest will continue to accrue, but an extension can give you the payment relief you need while saving your credit rating from adverse reporting of late payments. We will also make loans to payoff prior 401k loans so new 401k loans may be granted for those who qualify. It is our understanding that this must be done before a work stoppage occurs.

Additionally, now is a great time to bring other loans that you have financed elsewhere to your credit union. Other financial institutions may not be as easy to work with during a work stoppage or appreciate your situation as much as your credit union. To make this even more advantageous the credit union is offering a special incentive for the USW 105 membership by offering \$105 for each auto loan financed with a minimum loan amount of \$7,500 through August 31, 2018. All you have to do is enter **promo code: USW105** when you apply online or mention this offer when speaking with our staff. As part of this application process we will do a full account review to insure you are maximizing the benefits of being a member of Ascentra Credit Union.

We join all of you in the hopes that none of this will be necessary; however we appreciate the fact that the issues at hand are not easily rectified.
