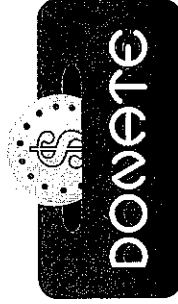

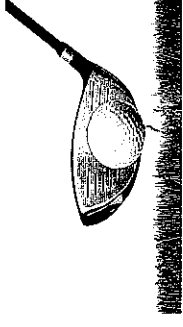


**Bucket Collection for
