LOCAL 105 NATHANIEL S. PAYNE MEMORIAL SCHOLARSHIP

Five - \$500 Local Union scholarships will be awarded to children of members of USW LOCAL 105 (active or retired). These educational scholarships, valued at \$500 each will be awarded to any child (natural, adopted, step, foster or grandchild) of a USW member who has been in good standing for the period of 2 years immediately prior to the date of the drawing (except for new hires with less than two years seniority). However, **only one applicant per sponsoring USW member may apply.**

Additionally, at the time of application each applicant must be enrolled full-time in this fall's semester or quarter of college and plan to attend full-time in the succeeding semester or quarter. Should a winner fail to register for the second quarter/semester the scholarship will be awarded to an alternate.

The scholarship application form on this page must be completed in full (please print or type) and must be signed by the Financial Secretary of Local 105 and affixed with the local union seal. Additional application forms may be obtained at the Union Hall 880 Devils Glen Rd. Bettendorf, Iowa.

Friday, December 7, 2018 is the deadline for submitting a scholarship application. Completed applications must be at the local office by 4:00 pm on the day of the deadline.
