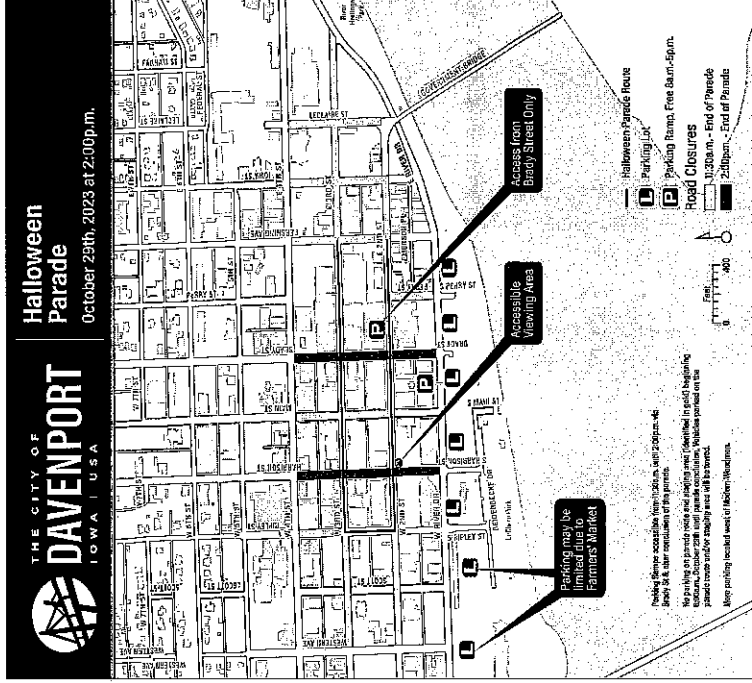

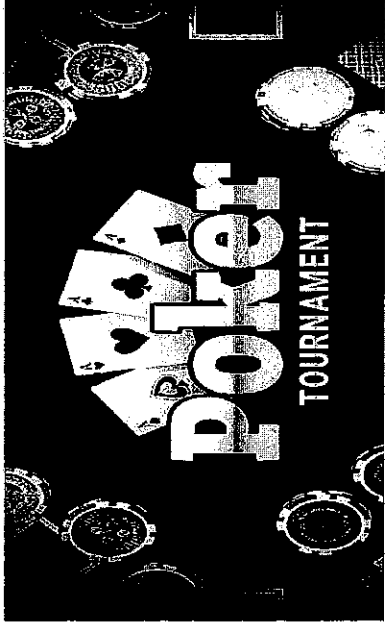

## Halloween Parade Update

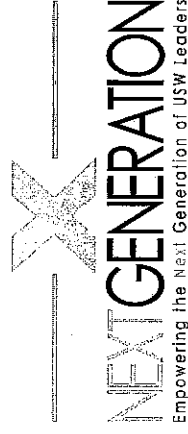
