There are some Arconic USW bargaining unit employees that are incorrect in believing they are not or will not be eligible for a pension when they retire. They are wrong!

If you quit before you become eligible to retire, you could be eligible for a pension when you reach a certain age if you have completed the five year vesting requirement.

LOCAL 105 NATHANIEL S. PAYNE MEMORIAL SCHOLARSHIP

Five - \$500 Local Union scholarships will be awarded to children of members of USW LOCAL 105 (active or retired). These educational scholarships, valued at \$500 each will be awarded to any child (natural, adopted, step, foster or grandchild) of a USW member who has been in good standing for the period of 2 years immediately prior to the date of the drawing (except for new hires with less than two years seniority). However, only one applicant per sponsoring USW member may apply.

Additionally, at the time of application each applicant must be enrolled full-time in this fall's semester or quarter of college and plan to attend full-time in the succeeding semester or quarter. Should a winner fail to register for the second quarter/semester the scholarship will be awarded to an alternate.
