


Valet parking is available at the rate of \$40 per day. Self-parking is \$14 per day/ \$21 for in/out privileges.

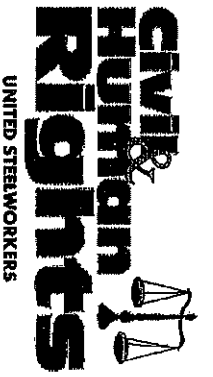
Remember, Local Unions are responsible for expenses of conference attendees. We look forward to greeting your delegation at the conference.
